RULES AND CONDITIONS FOR APPLICATION

1. A photocopy of the craft's current **Wisconsin** State registration, (2) photocopy of valid Certificate of Insurance, and (3) photograph of actual craft, must be on file for final application approval.
2. Seasonal occupancy of mooring space in the Village of Fontana shall be assigned to boat owners according to the following priority system: (a) On current waiting list as of November 20, 2002 which is on file at the Village Hall and the Village website at www.villageoffontana.com; (b) Year round Village of Fontana resident (taxpayer and registered voter); (c) Part time Village of Fontana resident (taxpayer but resident and voter in another municipality); (d) Fontana Property Owners of Buildable Vacant Tax Parcels, Dockominiums, and Condo/Hotel Unit owners; (e) Non-resident in which application is only considered if all above priorities are satisfied.
 - a. For purposes of this application a Village of Fontana Resident shall be limited to the owner of an interest in a Village residential tax parcel or an interest in an entity which owns a Village residential tax parcel.
 - b. No more than one application may be approved on behalf of any one Village buildable tax parcel.
3. **The application for a mooring must be completed in its entirety including proof of ownership (boat title and registration) before Monday, March 12, 2012. Applications postmarked after Monday, March 12, 2012, or missing information will be considered late and the mooring may be awarded to the next person on the list.**
4. If applicant purchases a new/used craft other than what is listed on this application, the applicant shall notify the Village Hall within seven (7) days after the purchase is complete to update this Application.
5. If any information contained in this application changes, the applicant shall notify the Village Hall before entering into a Lease Agreement with the Village.
6. Please make checks payable to: Village of Fontana or pay using www.officialpayments.com, jurisdiction code 6752, Miscellaneous Fee. (Fees include 5.5% State & County Sales Tax.) Enclose fee with signed agreement and **all** required boat documentation.
