NOTICE OF REFERENDUM

Big Foot Union High School District

NOTICE IS HEREBY GIVEN that a referendum election shall be held in the Big Foot Union High School District, on Tuesday, April 2, 2013, for the purpose of approving or rejecting a "Resolution Authorizing the School District Budget to Exceed State Revenue Limit for Recurring Purposes," adopted by the School Board of said School District on January 21, 2013.

Said Resolution reads as follows:

The Board of Education for the Big Foot Union High School District of Walworth County, Wisconsin, resolves that the revenues included in the School District Budget be authorized to exceed the revenue limit set forth in Section 121.91, Wis. Stats., on a recurring basis by \$300,000.00 for the 2013-2014 school year and on a recurring basis by an additional \$350,000.00 for the 2014-2015 school year for recurring purposes consisting of maintaining educational programming, safety and maintenance.

The question will appear on the ballot as follows:

Shall the Big Foot Union High School District be authorized to exceed the revenue limit set forth in Section 121.91, Wis. Stats., on a recurring basis by \$300,000.00 for the 2013-2014 school year and on a recurring basis by an additional \$350,000.00 for the 2014-2015 school year for recurring purposes consisting of maintaining educational programming, safety and maintenance?
