To vote for a person whose name does not appear on the ballot, write the person's name on the line(s) provided and completely darken the oval to the LEFT of the person's name like this . **When voting for president or vice president, you may vote only for the candidates on one ticket jointly or by writing in the names of persons in both spaces. A write-in vote only for a vice presidential candidate will not be counted.**
